DISCUSSION:

COMBAT Director-

- Application window for 2023 Funding opened on August 4
 - Applications for reviewers have also been received and reviewed
- COMBAT Strategic Plan Completed for 2022-2027
 - Began with surveys from COMBAT administrative staff, Legislators, Commissioners, and other key stakeholders
 - Process included a 2-day in person work session with COMBAT staff and Commissioners to develop new mission, vision and value statements as well as set long-term goals
 - Established Priorities
 - Raising Awareness in the Community
 - Collaboration with Funding Partners
 - Measure and Demonstrate Effectiveness
 - Enhancing Technological Resources
 - Goals
 - Increase STRIVIN referrals

 - Facilitate greater collaboration among law enforcement agencies and COMBAT-funded departments
- COMBAT's Communication Marketing Administrator, Joe Loudon, is raising awareness about Fentanyl and the risks through means of social media postings, information on COMBAT's website, as well as a Brochure (which is also available to download on the website)

Jackson County Drug Task Force-

- 2022 2nd Quarter Statistics
 - o 35 new investigations initiated, 233 Federal Cases filed for Prosecution, 28 State Felony Cases filed for Prosecution, 21 Municipal cases filed for Prosecution, 57 Drug Purchases, 20 search warrants, 47 Federal Warrants, 1 State Felony Warrant, 10 Municipal Warrants, 114,408.57 g (252 pounds) methamphetamine, 9,306.46 g (20.5 pounds) cocaine, 4,529.26 g (9.98 pounds) heroin, 9,905 g (21.8 pounds) Fentanyl, 4,445 Counterfeit M-30 pills (Fentanyl), 142 Prescription Pills (Adderall, Xanax), 6,309 g (13.9 pounds) THC/Edibles/Vape Cartridges, 50,337.70 g (110.88 pounds) marijuana, 55 firearms and \$294,525 cash U.S. Currency
 - Approximate Street Value of seized drugs: \$19,041,160
- The Task Force conducted a controlled purchase of approximately 2 grams of carfentanil. Detectives arrested the seller immediately after the transaction recovering additional carfentanil. Field tests confirmed the presence of carfentanil. The suspected carfentanil was sent to the laboratory for further testing.
 - Veterinarians use carfentanil to anesthetize large animals and is an analogue of fentanyl. Carfentanil is reportedly 100 times stronger than fentanyl.
