JC Drug Task Force- In February, two (2) enforcement operations were conducted resulting in the listed recovery of methamphetamine, weapons, and cash:

- 1. A search warrant of suspected methamphetamine conversion laboratory recovered:
- Juvenile trafficking victim

- 19,976g (44 pounds) methamphetamine (liquid/powder)
- 4 firearms
- \$31,000.00 cash

Narcotics street value approximately \$2.3 million dollars.

- 2. Targeted transport vehicle interdiction stops (out of state) recovered narcotics:
- 4,973 g (11pounds) methamphetamine

Street value approximately \$597,000.00
